

The APEDA registration will automatically stand cancelled if the member fails to export during the period of 12 months. It may please be noted that in the case of merchant exporters, there is no need for renewal of the Certificate as stated above. However, the manufacture exporters should have a valid certificate of registration of their unit as SSI/Large scale unit other concerned government authorities for renewal.
